## PRECAUTIONARY STATEMENTS

### HAZARD TO HUMANS AND DOMESTIC ANIMALS

## DIRECTIONS FOR USE

**MIXING DIRECTIONS:** Mix according to the directions for use on insecticide label. Add one capful (25 mL) of **BioAmp AA** per finished gallon of insecticide mix. Maintain constant agitation during mixing and application.

**APPLICATION DIRECTIONS:** After mixing one capful of **BioAmp AA** to the final insecticide mixture, apply according to the Directions for Use of the insecticide.

DO NOT use **BioAmp AA** from damaged, punctured, or unsealed containers. Use piston, diaphragm, or centrifugal pumps ONLY. DO NOT use roller or gear pumps as they will damage the **BioAmp AA** controlled release system. DO NOT use strainers or screens in spray equipment with openings smaller than 50 mesh. For best results, apply immediately after mixing. Do not let stand prior to application without thoroughly mixing again. Do not apply this product through any type of irrigation system.

## GENERAL INFORMATION ABOUT BioAmp AA

**SUTERRA BioAmp AA** is a microencapsulated formulation of the trail pheromone of the Argentine ant (*Linepithema humile*). **BioAmp AA** has no insecticidal properties of its own. The product is added to insecticide sprays in order to synergize the effect of these sprays by increasing ant movement and activity in areas where the insecticide is applied. This increases the exposure of the ants to the insecticide, providing greater efficacy. **BioAmp AA** is intended for mixing and application with non-repellent insecticides only.

## STORAGE AND DISPOSAL

**DO NOT contaminate water, food, or feed by storage or disposal.** **STORAGE:** Store in a cool place until used. Reseal containers immediately after use. Protect from freezing.

**DISPOSAL:** Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

**CONTAINER DISPOSAL:** Plastic Containers: Nonrefillable container. Do not reuse or refill this container. Triple rinse (or equivalent).
