## DIRECTIONS FOR USE

BRANDT NO FOAM B is an APE-free, non-ionic surfactant blend designed to increase the efficiency of herbicide and insecticide applications by providing exceptional wetting and uniform coverage. Listed pesticides sensitive to alkaline hydrolysis benefit from its acidifying and buffering properties. This product may be used on agricultural, forestry, turf and ornamental, industrial, structural and non-cropland sites. It should also be used to buffer highly alkaline water.

Read and follow the precautions, restrictions and recommendations on the labels of herbicides and insecticides used with BRANDT NO FOAM B. Use according to the most restrictive label directions for each product in any tank mix.

**COMPATIBILITY:** BRANDT NO FOAM B is compatible with most listed pesticides. However, if the desired combination has not been previously used, a compatibility test is recommended.

**MIXING:** Shake well before using. Fill spray tank 1/2 full of water and begin agitation. Add the recommended amount of BRANDT NO FOAM B. Add herbicides and insecticides as directed by label or in the following sequence and continue filling tank: (1) Dry flowables or water dispersing granules, (2) Wettable powders, (3) Flowables, (4) Solutions, (5) Emulsifiable concentrates. Continue agitation until spray solution is completely mixed. Continuous agitation of finished spray is recommended. If spray solution has been allowed to stand, thoroughly agitate and remix before application.

**RECOMMENDATIONS:** Proper quantity to use will vary with the type of equipment, water volume per acre, temperature, type of foliage to be wet, and the pesticide formulation. Also, higher rates than those below may be used if recommended by herbicide and insecticide labeling. Follow pesticide label directions. However, do not add this product at a rate which exceeds 5% of the finished spray volume.

**Air or Ground:** Use ½-3 pints per 100 gallons of finished spray solution. For improved efficacy, use at least ½ pint per acre when finished spray volume is less than 20 gallons per acre. For backpack or hand held sprayers, use 1 fl. oz. per gallon of finished spray solution.
